The call brought together MAG participants interested in joining the working group and the former chairs Julian and Flavio. The 2019 co-chairs were confirmed as June Paris (2<sup>nd</sup> year MAG) and Chenai Chair (1<sup>st</sup> year MAG). The MAG WORKING GROUP ON IMPROVEMENTS TO THE INTERNET GOVERNANCE FORUM - IGF 2018 Status Report was presented by the former co-chairs and proposed areas of future work for 2019-2020.

**The presented report pulls together proposed areas of improvements** collected from inputs process from various sources. It provides a classification of these improvements into a set of categories and tags. The goal of the WG was to prepare an assessment of all these recommendations, so that the community can see how far the IGF has progressed. The previous WG pulled together 11 categories and highlighted their status of completion as in the table below.

The purpose in calling for review from other WG is for them to review results that may affect the progress of their working group. The wider community will also be called up to contribute to the working document.

The first steps will be a call for volunteers in the MAG call as well as the wider IGF community. The deadline set for an internal review of the proposed areas are the 10<sup>th</sup> of July.

In preparation for the IGF 2019, it was proposed that the WG will organise a bilateral room where they can present their findings to the community. The purpose of this being to present the work that has been done by the group since 2017 and collect feedback that may be used for the 2020 report.
