Summary

Taking Stock of WSIS

The panellists discussed the successes of the World Summit on Information Society (WSIS) in the last two decades, including the rapid expansion of Internet access and the multistakeholder approach, which has contributed to this achievement. The open standards, open architecture, interoperability and inclusivity promoted by WSIS have also been a factor in the robust state of digital affairs today.

WSIS is an adaptable framework that has evolved over the years to address the challenges and opportunities presented by digital change. Panellists emphasized WSIS must be kept relevant in the face of rapid advancements, particularly in Artificial Intelligence.

Inclusive Multistakeholder Approach

WSIS has held multistakeholderism as a fundamental principle that has ensured diverse perspectives, including those of women and youth, are front and centre in shaping policies and solutions related to digital technologies. These perspectives are ever-critical within policy dialogues, especially those of youth, as technologies develop.

Addressing Digital Inequality

Digital inequality and exclusion have persisted – even if incremental progress has been made. Panellists called for keeping meaningful and equitable connectivity for all at the heart of the WSIS project. Addressing digital divides, including infrastructure, policy, and capacity divides, was identified as crucial for access.

IGF's Role

The IGF was recognized as the key platform for multistakeholder discussions on digital policy. Panellists underscored the value of IGF and its continued role in providing advice and recommendations to inform policymaking processes.

Evolution

WSIS was described as an evolving process that should continue to adapt to the changing technology and policy landscapes, especially in light of the "fragmentation of governance" risk. The framework



established by WSIS, including principles of openness, inclusivity, and multistakeholder collaboration, remains relevant for addressing future challenges and opportunities.
